Rationale

- These data permit the evaluation of the ability of participating departments, divisions, or interdepartmental programs to recruit trainees.
- These data are useful in assessing the appropriate number of training positions to be awarded.
- These data also provide information about the characteristics of program entrants and, for renewal or revision applications, training grant appointees.

- **Describe** the recruitment process for postdoctoral trainees (e.g., whether candidates are selected from individuals in the laboratories of proposed faculty members or whether there is a formal application process to the training program).
